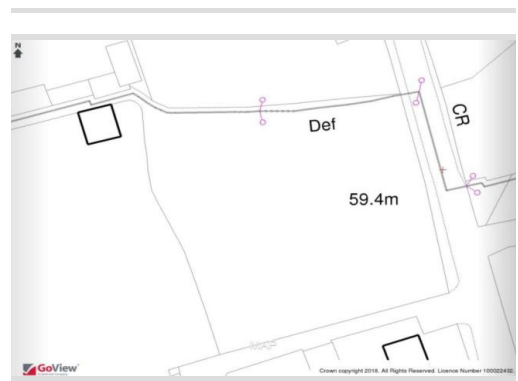
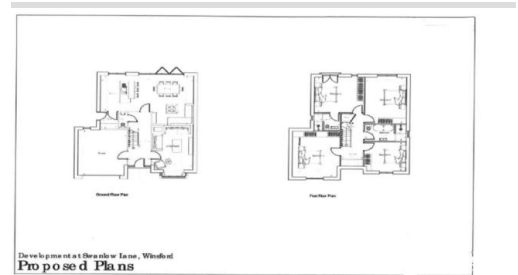

DETAILED PLANNING

Planning permission was granted on the 12th July 2016 by the Secretary of State for Communities and local Government. The application stands with the terms of the original application which means that development must commence no later than three years from the date of the decision.

Further clarification for this must be sought from your legal representative.
